



LOSS DAMAGE WAIVER

This Loss Damage Waiver (the 'LDW') protects _____ (the 'Participant') from financial responsibility for accidental loss or damage to vehicles caused by the Participant while participating in;

operated by Scenic Rush Driving Experiences Inc. (the 'Company') of #2 – 5775 Marine Drive, West Vancouver; up to the maximum amount of LDW coverage chosen on the next page, less the applicable deductible.

Coverage is not provided for loss due to: (a) any loss which occurs if the Participant is in violation of the Company's Safety Agreement; (b) any unlawful acts committed by the Participant or a traveling companion; (c) misuse, misconduct, or negligence by the Participant; (d) intentional damage; (e) failure to comply with instructions from Company personnel.

Coverage is not provided if the Participant has intentionally concealed or misrepresented any material fact or circumstance relating to the claim.

Coverage is not effective unless all premiums have been paid prior to the start of the Activity.

This waiver does not cover damage to property, medical expenses or personal injuries.

The Company will place a pre-authorization hold on the Participant's credit card (the 'Damage Deposit') for the Deductible amount of the LDW Package chosen. The Damage Deposit will be released upon conclusion of the Activity if there are no losses or damages to the Company's vehicles.
